2019 CFDA – NEW CLUB AFFILIATION ADDENDUM

Pro-Rated Affiliation Fee Worksheet

This addendum is a worksheet for calculating Affiliation Fees for New Clubs that are formed at different times of the year other than the Annual Club Re-Affiliation Time Period for existing clubs, which has a submittal deadline of December 7th.

NOTE: New Clubs affiliating after the Re-Affiliation Time Period who wish to participate in the NRA/CFDA Club Liability Insurance Program, still qualify for that program, and gives them the ability to order liability insurance certificates that protect property owners which hosts their club's events. However, the club itself cannot be added mid-year to our policy that lists their club as a Named Insured, until the next Re-affiliation Time Period.

PRORATED FEES FOR NEW CLUBS AFFILIATING DURING THE YEAR:

There is really no reason for any club not to affiliated anytime during the year. CFDA welcomes new clubs at any time, by providing these easy to calculate Pro-Rated Affiliation Fees.

1. Since the **Annual Base Affiliation Fee** for U.S. Clubs is \$125, that calculates to **\$11.00 per full month**.
2. For Clubs wishing to join the **NRA/CFDA Affiliated Club Liability Insurance Program**, the 2019 Insurance portion of the Affiliation Fee is \$319, that calculates to **\$27 per full month**.
3. Combined Affiliation Fee: \$11 + \$27 = **\$38 per full month**.

Example: For a club wishing to affiliate on July 15th, they would submit a partial year's fee for full months of August, September, October, November and December; or 5 full months.

If a new club **opts out** of the CFDA - NRA Endorsed Shooting Club Liability Insurance Program, it would be **5 x \$11 per full month = \$55**. But they must still provide an Additional Insured Shooting Club Liability Insurance Certificate naming CFDA as an Additionally Insured.

If a new club **opts in** to the NRA/CFDA Endorsed Shooting Club Liability Insurance Program it would be **5 x \$38 per full month for a TOTAL PRO-RATED FEE = \$190**

New Clubs affiliating after September 30th can affiliate for the following year with one application, at the discretion of CFDA Management.

Prorated Affiliation Fee: \$11 per month (No Insurance) \$11 x ____ (Full Months) = \$ ____

International Club Note: (\$175.00 = \$15_{us} per month)

OR

Prorated Affiliation Fee & CFDA - NRA Endorsed Shooting Club Liability Insurance Program:

\$38 per month (With Insurance) \$38 x ____ (Full Months) = \$ ____
