As a vendor, you'll receive a vendor packet once you've set up your space, which includes 2 vendor badges, Nevada Sales Tax info sheet and sales tax form to fill out at the end of Saturday and that will be collected by our staff, and other informational forms.

We also would like to ask all vendor that upon arrival to please donate an item of at least \$30 or more to be auctioned at our Friday evening event. All proceeds go to our CFDA Scholarship Foundation which has helped 100's of our young members go to further their education. It's a wonderful fundraiser and we truly would appreciate it, or even a gift certificate is as well would be great!
