CFDA Club in the Works Application & Agreement

By signing and submitting this application and agreement, you are declaring your intension to form a CFDA Affiliated Club, **within 6 months**. Please contact us, if you are not ready to affiliate your new club and we will be glad to extend the time period. You have the option to affiliate your club at any time, as it only takes one member to start an affiliated club. If you wish to form a club immediately, bypass this form and directly submit a CFDA Affiliated Club Agreement.

Important: Affiliated CFDA Clubs are not franchises. While there are no guaranteed areas, we will not tolerate clubs within the same area (100 miles) to conflict with one another's club shoot schedules. We are all part of the same sport. Two cooperating clubs in the same area enhance the sport. Established dates take precedence.

While we recommend jotting down some goals on the lines provided, it's not necessary.

I understand that all members of our club are required to be CFDA members in good standing. I also understand that once we are affiliated, (for U.S. Clubs Only) we will qualify for the NRA Liability Insurance Program and it is up to us to supply to CFDA dates and locations that we wish to insure. Note: One location as many times as we want per year is covered under our Club Affiliation Fee, additional locations may be added with enough notice for \$40 each. I also understand and agree to keep at least 50% NRA membership in our club, by whatever means possible, as this is a requirement to qualify for the NRA Insurance Program.

Upon receiving this agreement CFDA will place our proposed club on cowboyfastdraw.com under the Affiliated Clubs Section, in the underlying "Club in the Works" section. I agree to be placed as the contact person for this club and will follow up on leads generated.

CFDA will send you the Club Start-Up Kit, at no charge, after receiving this application/agreement. The Club Start-up Kit includes some Gunslinger Gazettes, a rulebook, 3 decals, a sample poster with the CFDA Logo, a CFDA Club Affiliation Agreement, and some handy tips that you will find helpful in getting your new CFDA Club up and running as soon as possible.
