**Note #1: CFDA State Championships are an optional item. The base Sanction Fee has been reduced to \$800, for an additional \$400 for the Optional prize Gun.**

The following items apply to this agreement:

- CFDA Contest Rules and Guidelines.** The host club hereby agrees to provide all equipment, staff and contest areas; an to abide by the CFDA Gunslinger’s Rules & Guidelines Latest Edition for contest rules, regulations and policies set forth by CFDA management.
- CFDA Membership:** All contest participants must be current members of CFDA to participate. It shall be the host's responsibility to check membership cards (possession of a Life Member’s Badge is acceptable.) Hosts can collect outstanding dues and remit them to CFDA for expired members. If a contestant does not have a membership card and claims to be a CFDA Member in Good Standing, the Host can rely on the contestant’s word, but should make a note of this, since Host will be billed for any non-members that are allowed to compete in any Titled Championship. If the non-member claimed to be a member in good standing, after being asked by the Host, then CFDA Management will assume responsibility for collecting any unpaid dues.
- Insurance:** CFDA agrees to provide insurance for Titled Event for dates of said contest. It is the host’s responsibility to fill out and submit to the CFDA office an **Additional Insured Location Form** to the CFDA office at least two weeks prior to the contest, there is no charge for this insurance for CFDA Titled Championships. This must include the property owner’s name, physical address of the contest and any other information needed on the form.
- CFDA Logo:** Use of the CFDA logo is allowed for promoting the event. **CFDA should be used for flyers, trophies, plaques, buckles, applications, brochures, and advertisement** as long as they meet all requirements set forth in the Gunslinger’s Guidelines.

5. CFDA Championship Titles are the intellectual property of CFDA. CFDA retains all rights to regulate, administrate and promote the sport of Cowboy Fast Draw.
6. Contest Dates: Are on a first come, first serve basis; and according to "CFDA Titled Championships" Section in the latest Gunslinger's Rule and Guidelines.
7. Host Will Provide:
  - An actual ad, or electronic information for Hannah Calder to make your ad to [info@cowboyfastdraw.com](mailto:info@cowboyfastdraw.com), State Championship ¼ page, Territorial ½ Page.
  - Submit results to [info@cowboyfastdraw.com](mailto:info@cowboyfastdraw.com) in an electronic format that can be edited, i.e. Rich Text or Word, within 10 days of the completion on the match. We do not re-type results. Simply posting JPEG on Facebook does not meet submission requirements, as we need these for several reasons.
  - It is the host's responsibility to supply an article, along with digital pictures for publication in the Gunslinger's Gazette. Clubs are encouraged to post pictures from their event on the Cowboy Fast Draw Society/Facebook Group
  - The Host Club is advised to use the power of both the Cowboy Fast Draw Society/Facebook Group & the CFDA Telegraph to promote their event. We recommend preparing a Match Flier, Schedule, and Entry Form and emailing them to [info@cowboyfastdraw.com](mailto:info@cowboyfastdraw.com) as a PDF or Word attachment.
  - All Match Fliers and advertisements are required to state either 17-3/16" @ 15' or 24" @ 21'.
8. CFDA will provide:
  - 2 Championship buckles, for overall Men's and Ladies' Champion.
  - 2 Prize Six-Guns for Territorial & National Championships. Optional Prize Six-Gun available for State Championships. All CFDA Prize Guns will be shipped directly to FFL Dealers of the Prize Gun Certificate Holders. CFDA reserves the right to determine which firearm(s) are used. Host may award or use the Prize Gun Certificates to raise funds to support their event as they determine.
  - 2 Resident Champion Buckles (Man & Lady), which covers the area of the State, or Territory as stated in the CFDA Titled Championship.
  - Listing on Events Page in Gunslinger's Gazette
  - ¼ Page Ad (1/2 Page Territorial) in Gazette for at least one issue before the contest.
  - Published article and photos, subject to space limitations and editing. (Provided by host)
  - Listing on CFDA Website, with information and application downloads
  - CFDA Representative or Designated CFDA Regulator.
  - Insurance, unless the club provides their own policy.
9. If the host requests a CFDA Representative from out of their area, the Host will provide one free entry fee and lodging for the CFDA Representative. The Director of CFDA or Regulator Administrator may appoint a CFDA Regulator to represent CFDA.

**PENALTIES:** If this contract is not upheld by the host club, a representative of CFDA has the authority to remove a sanction, suspend insurance coverage and/or refuse future sanctions applied for by the host club.
