### **“Renewal Process”**

*(Updated: December 2021)*

***Thank You for making a commitment to our sport by attaining the rank of a CFDA Qualified Range Master!***

Since its inception in 2006, our Range Officer Training Program has raised the level of the Sport of Cowboy Fast Draw significantly. Safety, of course, has always been our primary concern. But also, having trained Range Officers and Range Masters is paramount in keeping our matches running consistently and efficiently.

#### **Renewal Process**

In 2020, The CFDA Regulator Posse was concerned that many approved Range Masters, have allowed their rank as a CFDA Qualified Range Master to expire, which is accomplished through “Continuing Education”. We felt that the lack of renewals were due to distance, time constraints at tournaments, and lack of opportunity to be signed off by a Regulator of Approved Instructor, in the months leading up to an expiration date.

For this reason, this process has been streamlined in order to assist Qualified Range Masters document their continued education, in order to qualify for renewal much easier, through documented proof in the form of a “Log Page”, that they can submit showing their proficiency at both the club and championship level matches. It is the hope of the Regulator Posse that this New Renewal Process will provide the documentation and inspiration to guide our Range Masters to continue their education.

As a Qualified Range Master you are qualified to instruct Range Officer Classes at your local club. This certainly helps your club members learn Range Operations so that your local matches run safe and smoothly. Plus, when your club members travel to CFDA Titled Championships. They will feel more confident in their expectation of Range Operations and will enjoy their “big match” experience much better, and will probably shoot better too.

RO Instruction for your club not only benefits your club, but it also reinforces your knowledge as well. Therefore, conducting RO Training also counts as Range Master continuing education, as do other services you perform at various events that can be found on the New Renewal Form.

# CFDA RANGE MASTER S RENEWAL REQUEST FORM

Range Master Renewal is required every 2 years. Since there is an Approved Range Master's List published on the CFDA Website, Range Master Cards are no longer issued.

There is no cost unless you wish to order an additional Range Master Pin. Please enclose \$9 to cover the cost of a new pin, if you would like to receive one, which includes postage.

## Renewal Process Includes the Following Minimum Requirements:

- ◆ Complete and Submit this Request Form
- ◆ Submit Copy of Page(s) of Your Range Master Log Book

Note: Your Current Expiration Date may be found at: CowboyFastDraw.com, in the Range Officer Training Section, under Approved CFDA Range Masters

## At Least One Page Must Be Submitted Containing Seven Entries Using Any Combination of the Following:

- ▶ Range Mastering at a Class "B" or Higher Event (*Running at least 4 Groups*)
- ▶ Serving as an Announcer at a Class "B" or Higher Event. (*Running at least 4 Groups*)
- ▶ Instructing a Range Officer Class at a Local Club.
- ▶ Attending a Range Master's Course as a Refresher.
- ▶ Serving as Match Director or Chief Range Master at a Class B or Higher Event.
- ▶ Serving as a Match Director at a Class "C" Event.
- ▶ Organizing and Serving as Chief Range Master at a Try Cowboy Fast Draw Event (According to CFDA Guidelines)
